ERC Program

Background & Eligibility

ERC is a payroll tax credit that allows business owners to receive cash back per employee retained during COVID. If you started your business after 2/15/20, had W-2 employees, and averaged \$1M or less in gross receipts, you may qualify.

Funding

Our ERC Fast Track program allows qualifying businesses to receive their ERC refund within days of filing with the IRS, not months.

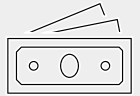

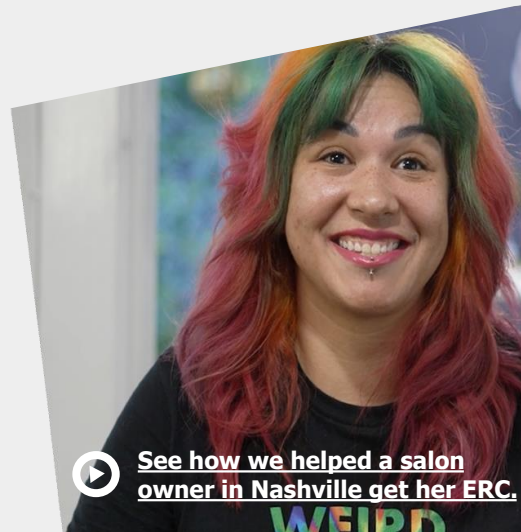
